REGULAR MONTHLY MEETING FEBRUARY 20, 2025

The five hundred fifty-fourth meeting of the City Pension Fund for the Firefighters and Police Officers in the City of Pembroke Pines was called to order at 1:03 PM by Chairman Robert Johnson.

- 2. Informal Disability Hearing Jordan Forsythe: Attorney Greenwood introduced Pembroke Pines Police Officer Jordan Forsythe's application for consideration and reviewed the protocols and appropriate motions for the hearing. At the informal level, the Board must focus only on the materials provided, including the written opinions of the doctors and any statements made during this proceeding solely by the applicant. Motion by Jack McCluskey, second by Jason Palant, to adopt and accept the medical files and submitted documents into the record. The motion carried unanimously.
 To receive approval of a service-incurred disability, the following criteria must be met:
 - 1. The injury sustained must have caused a total disability.
 - 2. The disability must be permanent.
 - 3. The injury must be incurred in the line of duty.

On point 1, since the City released Mr. Forsythe from his employment as a police officer, the totality portion of his disability is satisfied.

On point 2 – <u>Motion by Thomas Moran, second by Jason Palant, declaring Mr. Forsythe's disability is permanent. The motion carried unanimously.</u>

On point 3 – <u>Motion by Cody Stogner, second by Raphael Borrero, declaring Mr. Forsythe's disability is service-related.</u>

Motion by Jason Palant, second by Raphael Borrero, to grant former police office Jordan Forsythe a service-connected disability with benefits effective 5/21/24. The motion carried unanimously.

- **FYE 9/30/2024 Pension Fund Audit Results:** Eric Leventhal of KSDT & Company presented the Audit results for FY 2024. He presented a clean report indicating that the 2024 financial statements are a fair representation of the fiduciary net position of the Plan. Motion by Tim Anderson, second by Jack McCluskey, to accept the FYE 9/30/2024 Pension Fund Audit Results as presented. Motion by Jack McCluskey, second by Jason Palant, authorizing the Chairman to sign the financial statements into record and to sign the management representation letter. The motion carried unanimously.
- **4. Polen Capital:** Anthony Xuereb presented the firm's performance for the guarter ending 12/31/2024.

- **Corient:** Adrian Sancho and Robert Maddock presented the firm's performance for the quarter ending 12/31/2024.
- **Dahab Associates:** Greg McNeillie of Dahab Associates discussed the overall performance of the portfolio. As of December 31, 2024, the Fund performance is 0.1% for the quarter and was valued at \$990,877,788 representing an decrease of \$3,868,847 from the previous quarter ending value.

Gross & Net Rate Returns for Q/E 12/31/2024: The Board reviewed the gross and net of fees rates of return for Q/E 12/31/2024, as submitted by Dahab Consulting. Motion by Tim Anderson, second by Cody Stogner, to approve gross 0.10% and net (0.01)% rates of returns for the quarter ending 12/31/2024. The motion carried unanimously.

As discussed at a previous performance summary, Blackrock is on watch due to underperformance. The Board will issue a real estate RFP later this year.
